## PROJECT 24 - GENERAL

### PROGRESS REPORT - 12 APRIL 2016

Effective date: 12 April 2016

Thank you to everyone that was involved with the drafting and amendment process of Project 24.

The project is now well on the way to completion and we plan to have the first completed set ready by end of June 2016. The technical standards will then follow and should be completed before year end.

There are two rounds of meetings for each Focus Group left before the completion of the draft of the regulations. The first of which are taking place on 10 and 11 May '16 and the next on 20 and 21 June '16. All comments on regulations from industry must be in by 06 May '16 to enable the groups to discuss these in the next meeting, in order to have the regulations completed by June 2016.

After the completion of the draft regulations, input will be required from industry on the Technical Standards for all the above regulations. This is an important part of the regulatory process which we plan to have completed by November 2016.

These regulations are for you. It will affect your operation in future. Please have a look at these new regulations and let us have your comments should you think anything should be changed.
